- #4. Purchaser must enter the date the form is being executed on. Use MM/DD/YYYY format.
- #5. Purchaser is to input the number of packages being ordered:

- #10. Supplier DEA Registration No. is entered by Lifeline Pharmaceuticals, LLC. Do not enter any information in this field.
- #11. The NDC is entered by Lifeline Pharmaceuticals, LLC. Do not enter any information in this field. If your order is NDC specific please direct that information to your Account Executive.
- #12.The Packages Shipped is entered by Lifeline Pharmaceuticals, LLC. Do not enter any information in this field.
- #13. The Date Shipped is entered by Lifeline Pharmaceuticals, LLC. Do not enter any information in this field.

Purchaser will separate and retain the blue copy (copy 3) of the DEA 222 form and complete the Packages Received and Date Received entries upon receipt of the order or notification that an order/line item has been cancelled.
